Secure provisioning is provided through the KSGC Information Security Team, which securely provisions your environment utilizing your organization's directory. KSGC is compatible with any SAML 2.0=compatible identity provider, including Azure Government Cloud, Okta, Duo and Ping.

Auditing and Reporting

KSGC simplifies compliance monitoring and reporting with robust internal controls, including delegated administration, enforcement policies, event tracking, monitoring and customizable audit logs and event reporting. Through a central dashboard, IT administrators can view and run reports on password security across the organization.

Compliance and Security

KSGC meets FedRAMP, FIPS 140-2 and ITAR compliance requirements and supports compliance with NIST 800-63B, FITARA, CMMC, HIPAA, DPA, FINRA, SOX and more, with detailed, user-level reports that show privileged access and permissions to critical systems, credentials, and secrets.
