Without a way to spot and reconcile these gaps, your firm may face stiff penalties and reputational damage.

#### **Compliance Gateway**

Proofpoint Compliance Gateway keeps you compliant and in control. Captured content is delivered to the Compliance Gateway, which creates a report and routes the content to its final destination. Compliance Gateway then compares the report of captured content against an ingestion report from the downstream service. Content that is missing or cannot be reconciled is automatically resubmitted.
